The undersigned, for the purpose of forming a corporation on under Section 402 of the Not-For-Profit Corporation Law, hereby certify:

- (1) The name of the corporation is:
 "PINE HILLS NEIGHBORHOOD ASSOCIATION, INC."
- profit or financial gain, and shall not be conducted or operated for profit, and no part of the assets or net earnings is distributable to or shall inure to the benefit of its members, directors or officers except to the extent permitted under the Not-For-Profit Corporation Law. Upon any dissolution of this corporation no member shall be entitled to any distribution or division of its remaining property or its proceeds, and the balance of all money and other property of the corporation shall be used or distributed, subject to the order of the Supreme Court of the State of New York, as provided by law, exclusively for purposes within those set forth in paragraph 3 of this Certificate of Incorporation and within the intendment of Section 501(c)(3) of the Internal Revenue Code of 1954, as the same may be amended from time to time.
- (3) The purpose for which this corporation is to be formed are the following civic purposes:

(a) To aid in the repair, rehabilitation and restoration of existing endangered dilapidated and substandard dwelling units.

- (b) To aid and assist in the development of projects, research and other activities in cooperation with state and local governmental agencies, civic and community organizations, banking institutions, insurance companies and other lenders, both public and private, for elimination of slums, blight and blighting influences.
- (c) To aid, assist and foster the planning, replanning, development, renewal, redevelopment and improvement of housing conditions principally in the Pine Hills Area of the City of Albany, County of Albany, State of New York.
- (d) To provide a forum for the people living in the Pine Hills neighborhood to express their concern on community issues.
- (e) In furtherance of these purposes this corporation shall have all the powers enumerated in Section 202 of the Not-for-Profit Corporation Law.
 - (4) This corporation is a Type B corporation.
- (5) Its office is to be located in the Gity of Albany, Albany County, and the State of New York.
- (6) The territory in which the corporation's activities are principally to be conducted are the County of Albany.
